The entries can be sent through the official channel to the Ju-Jitsu Association of India to the E-mail office@ju-jitsu.in. The units, who fail to send the team entries on or before the given deadline, will not be entertained. Kindly be informed that as per the guidelines of the Ministry of Youth Affairs & Sport and the Sport Authority of India, the Women coach / manager should accompany with the Girls team. The list of the technical officials who will serve in the Ju-Jitsu National Championship - 2025 be share to all units shortly.

All state in-charge are requested to pay the affiliation fees for their respective State units. No team will be allowed to take part unless all or any pending dues and annual affiliation fees is not cleared to the association.

During the registration of players all the state units are directed to bring and submit the Team entry form duly filled, signed & stamped by the President / Secretary of the State Association along with the requisite documents like Date of Birth proof [02 xerox copy of the Adhaar card], 02 Passport size photo, Athlete's commitment & Indemnity form, Waiver of Liability form and Athlete's health declaration form [Medical Fitness certificate] etc.

The details & general / technical rules & regulations of the Ju-Jitsu National Championship – 2025 are mentioned in the Proclamation of the event for your information and necessary action.
